Prospective purchasers are advised to refer to the sales brochure for the development for information on the development.

- (2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條， -  
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

#### 第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

#### 第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

#### 第53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase-

(i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

5% of purchase price : shall be paid by the Purchaser upon signing of the Preliminary Agreement for Sale and Purchase.  
The Formal Agreement for Sale and Purchase shall be signed at the designated solicitors' office within 5 working days after signing of the Preliminary Agreement for Sale and Purchase.

- (i) "designated bank" offer first mortgage loan, second mortgage loan will be offered by finance company(ies) arranged by the Vendor (the maximum amount of second mortgage loan offered shall not exceed 40% of the "Net Purchase Price", and the total amount of first mortgage loan and second mortgage loan offered shall not exceed 90% of the "Net Purchase Price"). Purchasers will have to pay monthly instalments and interest will be accrued starting from the day of drawdown and interest on second mortgage loan will be calculated at 2% below the Hong Kong Dollar Best Lending Rate (P-2%p.a.) as quoted by The Hongkong and Shanghai Banking Corporation Limited ("the Best Lending Rate") from time to time for the first 24 months ; and at 1% below the Best Lending Rate(P-1%p.a.) within the period from the 25th month to the 36th month; and thereafter will be calculated at 1% above the Best Lending Rate (P+1%p.a.), subject to fluctuation. 5% of purchase price : shall be paid by the Purchaser upon signing of the Preliminary Agreement for Sale and Purchase.  
The Formal Agreement for Sale and Purchase shall be signed at the designated solicitors' office within 5 working days after signing of the Preliminary Agreement for Sale and Purchase.
2. 樓價 5%：於買方簽署臨時買賣合約後30天內支付。  
5% of purchase price : shall be paid by the Purchaser within 30 days after signing of the Preliminary Agreement for Sale and Purchase.
3. 樓價 90%：於買方簽署臨時買賣合約後60天內支付。  
90% of purchase price : shall be paid by the Purchaser within 60 days after signing of the Preliminary Agreement for Sale and Purchase.

Without affecting the Purchaser's rights under the Formal Agreement for Sale and Purchase, the Vendor shall at its own cost and as soon as reasonably practicable after receipt of a written notice served by the Purchaser within 3 years from the date of the Assignment or the commencement date of the Licence (whichever is earlier) of the residential property rectify any defects (fair wear and tear excepted) to the residential property (excluding furniture (if any) and landscape area / potted plants (if any)) caused otherwise than by the act or neglect of any person.

Where the Purchaser chooses (A) or (B) payment plan stated in paragraph (5)(i) may apply to the Vendor for the purpose of early occupancy of the specified residential property as a licensee ("Licence"), subject to the following terms:

- (a) 買方須根據買賣合約向賣方繳付不少於樓價10%。  
The Purchaser shall pay to the Vendor not less than 10% of the purchase price.

- (b) 許可期限為許可生效日期後起計直至成交日(提早終止除外)；買方必須由簽署臨時合約後30日至簽署臨時合約後180日期間以書面向賣方提出許可申請，如買方於簽署臨時合約後30日前或180日後方提出申請，賣方保留權利，以賣方絕對酌情權決定是否授予許可。  
The term of the Licence is for a period from the commencement date of the Licence to the date of completion (subject to early termination). The Purchaser shall submit written application of the Licence to the Vendor for the Licence within the period from 30 days after the signing of the Preliminary Agreement to 180 days after the signing of the Preliminary Agreement. If the application is made before 30 days or after 180 days after the signing of the Preliminary Agreement, the Vendor reserves the right in its absolute discretion to decide whether or not to grant the Licence.
- (c) 買方須以上期形式繳付每年許可費用的金額相等於樓價2%。  
The Purchaser shall pay in advance a licence fee equivalent to 2% of the purchase price per annum.
- (d) 買方於接收該物業管有權之前須簽署一份經由賣方訂明的許可協議，許可協議的格式可於簽訂臨時買賣合約時於賣方代理人辦事處可供參閱。  
A Licence Agreement in a prescribed form of the Vendor shall be signed by the Purchaser before taking possession of the Property. The form of the Licence Agreement is made available for inspection prior to the signing the Preliminary Agreement for Sale and Purchase at the office of the Vendor's agent.
- (e) 買方須同意負責所有法律費用(包括就許可協議而產生的印花稅(如有))。  
The Purchaser shall bear all legal costs and expenses (including stamp duty (if any)) arising from the Licence Agreement.
- (f) 在許可期內，買方不須負責物業之相關管理費、地租、差餉，但買方須負責許可期內有關物業之其他開支，在簽訂許可協議時，買方須預付公契內所要求業主繳付的管理費按金或其他按金。  
During the licence period, the Purchaser shall not be required to pay any management fees, Government rent and rates but all other outgoings of the Property during the licence period shall be borne by the Purchaser and upon signing of the Licence Agreement, the Purchaser shall pay in advance the management fee deposit and other deposit payable by an owner as required under the DMC.

"The Special Set-off Rebate" shall only be used to set off part of the balance of purchase price upon completion.

- (b) 「傢俬津貼現金回贈」優惠計算得出的金額皆以四捨五入至個位整數。  
The amount of "Furniture Allowance Cash Rebate" Benefit will be rounded to the nearest dollar.
- (c) 如買方藉簽署臨時買賣合約購買發展項目中任何指明住宅物業，並在完成交易時清付指明住宅物業的樓價餘額，買方將可獲賣方提供金額相等於臨時買賣合約中列明的指明住宅物業的樓價2%之現金回贈(「傢俬津貼現金回贈」優惠)。  
Where the Purchaser purchases any specified residential property in the development by signing a Preliminary Agreement for Sale and Purchase and settles the balance of purchase price of the specified residential property upon completion, the Purchaser will be entitled to a cash rebate for an amount equal to 2% of the purchase price of the specified residential property as set out in the Preliminary Agreement for Sale and Purchase to be offered by the Vendor ("Furniture Allowance Cash Rebate" Benefit).

Upon completion and subject to settlement of the balance of purchase price of the specified residential property by the Purchaser, the "Furniture Allowance Cash Rebate" Benefit will be applied for part payment of the balance of purchase price directly. For the avoidance of doubt, the "Furniture Allowance Cash Rebate" Benefit shall not be applied for any purpose other than for part payment of the balance of purchase price as aforesaid.

"Early Completion Cash Rebate" Benefit

Prior to a prospective Purchaser(s) entering into a Preliminary Agreement for Sale and Purchase of a residential property, the prospective Purchaser(s) may enter into a lease (in such form and content as specified by the Vendor)(the "Lease") with the Vendor (as landlord) in respect of such residential property.

Under the Lease, the tenant will be granted an option to purchase the residential property at the price stated in this price list (subject to any applicable discount and together with any applicable gift, or any financial advantage or benefit as specified in this price list (as the same may be revised from time to time)), which option is only exercisable by the tenant after the 36th month of the lease term but on or before the expiration of the 39th month of the lease term. If the tenant fails to exercise the option to purchase in accordance with its terms and conditions, the option to purchase will lapse automatically and the tenant will not be entitled to any compensation therefor.

Subject to the compliance with all the following conditions by the Purchaser(s), the Purchaser(s) will be offered an "Option to Purchase Rental Rebate" :

- i. 買方(作為租客)與賣方(作為業主)就買方購買的住宅物業已簽訂一份租約，其中含有僅限於買方作為租客於租期第三十六個月後至租期第三十九個月屆滿或之前行使的認購權(租約格式及內容由賣方訂明)(「含有認購權之租約」)。  
The Purchaser(s) (as tenant) has entered into a lease containing an option to purchase which is only exercisable by the Purchaser(s) as tenant after the 36th month of the lease term but on or before the expiration of the 39th month of the lease term (in such form and content as specified by the Vendor) (the "Lease with Option to Purchase") with the Vendor (as landlord) in respect of the residential property purchased by the purchaser(s).
- ii. 買方為該已出租之住宅物業的現有租客。  
The Purchaser(s) is the sitting tenant of the leased residential property.
- iii. 買方在整個含有認購權之租約期內或直至住宅物業的買賣完成日為止(以較早者為準)已妥為履行及遵守含有認購權之租約的條款及細則。  
The Purchaser(s) has duly performed and observed the terms and conditions of the Lease with Option to Purchase throughout the term of the Lease with Option to Purchase or up to the date of completion of the sale and purchase of the residential property (whichever is the earlier).
- iv. 買方(作為租客)按照含有認購權之租約的規定已向賣方(作為業主)提供一份認購通知書(按含有認購權之租約所定義)(格式及內容由賣方訂明並附夾於含有認購權之租約)。  
The Purchaser(s) (as tenant) has duly served an Option Notice (as defined in the Lease with Option to Purchase) (in such form and content as specified by the Vendor and attached to the Lease with Option to Purchase) on the Vendor (as landlord) in accordance with the Lease with Option to Purchase.
- v. 含有認購權之租約下沒有欠繳租金。  
There is no rental arrears under the Lease with Option to Purchase.
- vi. 已出租之住宅物業之買賣須於已出租之住宅物業之租期屆滿時或之前完成。  
Completion of the sale and purchase of the leased residential property shall take place on or before the expiration of the lease term of the leased residential property.

Whereby：

1. 買方按照由買方作為現有租客身份妥為送達並由賣方接受的認購通知書(按含有認購權之租約所定義)的條款於簽署已出租之住宅物業的臨時買賣合約時，買方將相等於認購價(按含有認購權之租約所定義) 5%之由買方根據含有認購權之租約實際已支付的租金按金直接作為臨時買賣合約下所需支付的臨時訂金。  
Upon signing of the Preliminary Agreement for Sale and Purchase of the leased residential property pursuant to the terms of the Option Notice (as defined in the Lease with Option to Purchase) duly served by the Purchaser(s) as sitting tenant and accepted by the Vendor, the Vendor will apply the rental deposit actually paid by the Purchaser(s) under the Lease with Option to Purchase equivalent to 5% of the Option Price (as defined in the Lease with Option to Purchase) towards settlement of the preliminary deposit under the Preliminary Agreement for Sale and Purchase directly.

The "Option to Purchase Rental Rebate" Benefit is subject to other terms and conditions.

Any "Henderson Club" member who purchases any specified residential property in the price list of the development directly through Henderson Property Agency Limited (but not through the other estate agents) will be given management fees for the period of 24 months after the execution of the assignment of the residential property by the Purchaser.
