- (b) A tenderer who is a body corporate should clearly state its correspondence address, the name of its contact person and its telephone and facsimile numbers all of which shall be situate in Hong Kong, in the Form of Tender.
9. (a) In consideration of the invitation of tender by the Vendor and of the promise by the Vendor mentioned in paragraph 9(b) below, every tender shall constitute an irrevocable formal offer capable of and remain open for acceptance by the Vendor on the terms and conditions contained in this Tender Notice, the Form of Tender and the Conditions of Sale on or before the Date of Acceptance. After the Form of Tender has been submitted, no tenderer may withdraw his tender and the same shall be deemed to remain open for acceptance by the Vendor until the end of the Date of Acceptance.
- (b) In consideration of the provision and undertaking referred to in paragraph 9(a) above, the Vendor promises to pay each tenderer HK\$10.00 upon receipt of a written demand from such tenderer prior to his submission of his tender.
10. If a tender is accepted, the successful tenderer shall be the purchaser of the Property (the **"Purchaser"**) and:-

11. **CONDITIONS OF SALE**

1. In these Conditions of Sale, the following expressions shall have the following meanings except where the context otherwise permits or requires:-

<b>“Acceptance of Offer”</b>	means the Vendor’s acceptance of the Purchaser’s tender by signifying its acceptance in the Acceptance of Offer at the end of the Form of Tender and notifying the Purchaser pursuant to paragraph 10(a) of the Tender Notice.
<b>“these Conditions”</b>	means these Conditions of Sale.
<b>“Form of Tender”</b>	means the Form of Tender annexed hereto.
<b>“Formal Agreement”</b>	means the formal Agreement for Sale and Purchase to be executed by the Vendor and the Purchaser in accordance with Condition 5 of these Conditions.
<b>“Development”</b>	means <b>“THE UPPER SOUTH (逸南)”</b> , 71 Main Street, Ap Lei Chau, Hong Kong erected on SECTION A OF APLICHAU INLAND LOT NO.68, SECTION B OF APLICHAU INLAND LOT NO.68, SECTION C OF APLICHAU INLAND LOT NO.68 and SECTION D OF APLICHAU INLAND LOT NO.68 and the Property forms part of the Development.
<b>“Preliminary Agreement/this Preliminary Agreement”</b>	means the agreement made hereunder by virtue of the submission of the Form of Tender by the Purchaser and the Acceptance of Offer by the Vendor in accordance with the Tender Notice, the Form of Tender and these Conditions.
<b>“Preliminary Deposit”</b>	has the meaning ascribed to it under Condition 4 of these Conditions.

<b>“Property”</b>	means the Tendered Property set out in the Form of Tender immediately after the offer to purchase under the Form of Tender has been accepted by the Vendor.
<b>“Purchase Price”</b>	means the purchase price tendered in the Form of Tender by the Purchaser.
<b>“Purchaser”</b>	means the successful tenderer whose tender in respect of the Property is accepted by the Vendor.
<b>“Tender Notice”</b>	means the Tender Notice annexed hereto.
<b>“Vendor”</b>	means Wealth Full Investment Limited (發富投資有限公司).
<b>“Vendor’s Agent”</b>	means Henderson Property Agency Limited.
<b>“Vendor’s Solicitors”</b>	means Messrs. Vincent T.K. Cheung, Yap & Co.

2. The Form of Tender (with the Tender Notice and these Conditions of Sale) and the Acceptance of Offer shall constitute a binding agreement between the Vendor and the Purchaser for the sale and purchase of the Property. The Vendor shall sell and the Purchaser shall purchase the Property at the Purchase Price and on the terms and conditions contained in this Preliminary Agreement.
3. In this Preliminary Agreement:-
  - (a) **“saleable area”** has the meaning given by section 8 of the Residential Properties (First-hand Sales) Ordinance (Cap. 621) (the **“Ordinance”**);
